EPR reports on market trends and prices for coldwater as well as tropical species namely cod, hake, Alaska pollack, herring, farmed salmon/trout, European sea bass/sea bream, tuna, tropical shrimp and chephalopods and more.

is a quarterly newsletter focusing on Seafood Inspection, Quality Control, Post-Harvest Technologies and Food Safety. It is a joint publication of INFOFISH, FAO and International Association of Fish Inspectors(IAFI). The newsletter is available in English, Spanish, French and Portuguese.


